All games 21 ends, knock-out, no time limit. All dead ends to be replayed. All games will be played on undercover greens. Starting times each day: Game 1 at 9:00am, Game 2 after lunch.  
Preliminary rounds will be played at Souths Suburban and Mackay City on 27/28 February with the finals at Mackay City on Sunday 14 March 2021.
